Scholarship under the Government of Italy

With reference to letter No. NGA/I-82/3067 dated 31st March, 2016, the Royal Civil Service Commission is pleased to announce the availability of one scholarship under the Government of Italy for procurement officers in the civil service to pursue Master in Public Procurement Management for Sustainable Development course, University of Turin, Italy (2016/2017 intake).

Interested civil servant may submit the following documents to the HRD, Ministry of Finance latest by 7th April, 2016:

1. Mark sheet and certificate for both degree and class XII
2. CV (include status of BCSE select)

Due to time constraint (offer received on 1st April 2016 with 15th April 2016 as deadline), the RCSC has shortened the announcement and short listing timeline.

Scholarship detail

A. Course duration

- Course duration is for 9 months. It can be renewed after the completion of 9 months so that the student can continue for the second year and complete the 2-year Master course. The provision of 9 months is kept to ensure the student works hard and secures requisite grades to continue the second year

B. Scholarship status

- Stipend of 820 Euros per month will be borne by the Government of Italy
- Health insurance: for sole period of the scholarship granted by the Italian Government, the scholarship holder are covered by an insurance policy
- Airfare (round trip) has to be borne by the nominating country/agency (**RCSC**)

C. Eligibility/criteria

- Sponsoring country: Age limit of the candidate should be between 18-35 years (as of 15th April, 2016)
- Nominating country:
 - MoF to announce within Ministry for procurement officers (including procurement officers working in line agencies)
