- For non-native speakers the applicant should have the English proficiency equivalent to TOEFL (iBT) score of 60 or IELTS score of 6.0 or above.
- The applicant should understand the time commitment required for the completion of the program and therefore be willing to dedicate the required time and effort accordingly.

• The applicant should be able to adapt in a multicultural environment and be a model for a global citizen.

D. Scholarship conditions(PIM):

- iMBA Scholars must register for every semester. In case the student has to drop the semester due to unforeseen and uncontrollable reasons, he/she can request for permission to drop the semester with the Dean of The International College. However The Dean may or may not grant such permission depending on each individual case.
- iMBA Scholars are not allowed to disclose the details of their scholarship to their fellow classmates.
- iMBA Scholars are expected to become good brand ambassador of the program amongst their peers. This implies punctuality, work responsibility, class attendance and no misconducts such as plagiarism or other academic dishonesty.
- The Scholarship period is limited to 2 years only. In case of any iMBA Scholar taking more than 2 years to graduate he/she will be responsible for his/her own financing of the program.
- iMBA scholars are expected to follow all the guidelines, rules and regulations mentioned in the iMBA program handbook as well as PIM student handbook.
- iMBA scholars are expected not to engage in any activity deemed illegal as per the law of Thailand.
- The recipient of scholarship is expected for a voluntary work up to 8 hours per month whenever applicable. Such work will be related to either marketing or academic activity of iMBA program. Students are not required to stay in iMBA office to perform such work.
- The academic progress is reviewed every semester to assess the eligibility of scholarship: The iMBA Scholar must maintain his/her GPAX of 3.50 or above each semester to continue the scholarship funding except otherwise mentioned in the acceptance letter.
- Breach of Scholarship contract: Any breach of above conditions will result in termination of the scholarship contract and the scholar student is required to repay the scholarship amount mentioned in the acceptance letter in full in order to graduate from PIM. The PIM scholarship committee will have the final decision on the termination of the contract as well as decision on repayment.
