1. Eligibility

- a. The applicants should not have availed Master's Degree.
- b. Be 45 years of age or below as of 01st December 2016.
- c. Waiver of three years service requirement (for BSCE-Select graduates) to apply for IRS Course. However, MoF shall shortlist based on following sequence of priorities:
 - i. Those candidates who fulfill three years service requirement and who do not have any training obligations;
 - ii. Those who fulfill three years service requirement but have training obligations;
 - iii. Those who completed probation period but did not fulfill three years service requirement; and
 - iv. Those who are on probation period.

2. Documents Required

The following documents must be submitted to the Ministry of Finance (MoF) through Department of Revenue & Customs for shortlisting and MoF is requested to forward only the documents of shortlisted candidates to the RCSC for interview:

- a. Updated and accurate CV from the CSIS for rural posting and seniority calculation;
- b. Copy of pass Certificates and Academic Transcripts of Class XII and Degree;
- c. Duly filled In-Service Training Form (Annexure 9/3 of BCSR 2012);

The following documents (including their reference numbers and dates) need not be submitted/mentioned:

- i. Course content & schedule from the Institute; and
- *ii.* Letter of Acceptance from the Institute.

3. Application Deadline

- a. The application documents should reach Ministry of Finance on or before 31st May 2016;
 and
- b. The MoF must submit the application documents of the shortlisted candidates to the RCSC on or before **06**th **June 2016**.

4. Special considerations/waiver for IRS by RCSC's Commission

- a. For IRS (Customs & Central Excise) and IRS (Tax) which is a PG Diploma:

 Upon successful completion, they can immediately go for next trainings (both short-term and long-term) without having to maintain the training gap as per BCSR 2012. [For previous batches of IRS (Tax) which is a Master's Degree, they can go for next Masters only if it leads to specialization and also must maintain the required training gap as per BCSR 2012.]
- b. The duration of IRS course shall have no impact on one's study leave of 36 months with pay while going for next long-term trainings.
- c. The IRS training duration shall be considered as active for the purpose of promotion (only) but not eligible for promotion during study period.
- d. In case of resignation, the training obligations shall apply and one must be liable or financial obligations as per BCSR 2012.
