Target Group

1. Dzongrabs, Drungpas and those RCSC-Select graduates with PGDPA/PGCDM from the Royal Institute of Management (RIM).

Eligibility Criteria

1. The clause on ineligibility during probation period shall not apply.
2. Dzongrabs & Drungpas applying for the course should possess a Bachelor's Degree and they should be 45 years of age or below at the time of commencement of the course.
3. The applicants should not have availed any training funded under Government of India especially the TCS of Colombo Plan or ITEC/SCAAP Programme before.

Documents Required

1. CI-XII and Degree Mark Sheets & Pass Certificates.
2. PE Ratings for the last two years (*first & last pages only*).
3. In-service Training Form

The following documents need not be submitted at the time of application. Also their reference numbers and dates need not be quoted in the form:

- i) Online Security Clearance Certificate;
- ii) Audit Clearance Certificate;
- iii) Medical Fitness Certificate;
- iv) Course content & schedule from the Institute; and
- v) Letter of Acceptance from the Institute.

However, if selected, documents from i) - iii) have to be submitted to the agencies concerned during on-line nomination through CSIS.

Obligation

Unlike in the past, a civil servant after availing courses such as IAS, IAAS, IRS and IFS shall not be required to fulfill training gap upon completion. Henceforth, such civil servants shall be eligible to apply for next scholarship immediately thereafter.
