1. Eligibility

- a. The applicants should not have availed Master's Degree.
- b. Be 45 years of age or below as of July 1, 2019.
- c. Waiver of three years' service requirement (for BSCE-Select graduates as per section 9.7.3.7 Of the BCSR 2018) to apply for IAS Course. However, shortlisting shall be done Based on following sequence of priorities:
 - 1st Priority: Those candidates who fulfill three years of service requirement and who do not have any training obligations;
 - 2nd Priority: Those who fulfill three years of service requirement but have training Obligations;
 - 3rd Priority: Those who completed probation period but did not fulfill three years of service requirement; and
 - 4th Priority: Those who are on probation period

2. Documents Required:

The following documents must be submitted to the respective parent agencies:

- a. Performance rating for 2 years (latest)
- b. Merit certificate (co-curricular, leadership, social service, special achievement, etc only received after joining service)
- c. Updated and accurate CV from the CSIS for rural posting and seniority calculation;
- d. Copy of pass Certificates, Academic Transcripts of Class XII, Degree, and other Merit certificates;
- e. Duly filled In-Service Training Form (Annexure 9/7 of BCSR 2018, Course content and Schedule from the Institute, and Letter of acceptance from the Institute need not be Submitted)

3. Shortlisting Criteria as per BCSR 2018

4. Application Deadline

- a. The application documents should be routed through Parent Agencies and submit to RCSC on or before June 15, 2019.

5. Special Consideration from the Commission:

- a. This course shall not affect three LTT limit (Section 10.11.2 of the BCSR 2018) as it shall be considered as career enhancement and leadership course.
- b. A candidate can apply for the course without maintaining training gap for the STT availed.
- c. A candidates can avail STT without maintaining gap of 12 months as per Schedule 9/A of the BCSR 2018 upon completion of the course.
- d. This course shall be considered as career enhancement and leadership courses and a Candidate will be eligible for another Master's Degree later.
- e. Full pay for the entire duration as per section 10.11.4 of the BCSR 2018
- f. Candidates can apply for positions within or outside the current working Agency Provided they fulfill the requirement of the receiving Agency.
