BCSE 2019: Placement and Selection details

Candidates who have obtained 50% and above in the Main Examination (M.E.) of the BCSE 2019 and **meet the prospect of being selected for the vacancies** already announced for the respective examination categories are required to report **in person** for Selection and Placement as detailed below:

Venue : Lungtenzampa Middle Secondary School (Auditorium)

Category/Date/Time

1. Technical Category - December 19, 2019 @ 9.00 a.m.
2. B.Ed. graduates - December 20, 2019 @ 9.00 a.m.
3. Dzongkha Category - December 23, 2019 @ 9.00 a.m.
4. PGDPA/PGDFM/PGDNL Candidates - December 23, 2019 @ 9.00 a.m.
5. PGDE candidates - December 23, 2019 @ 9.00 a.m.

The Selection and Placement shall be carried out based on the following:

1. Merit ranking of the M.E. results for the respective examination category; and
2. Availability of vacancy.

Further, the vacancies under PGDE (school teaching) not filled from the PGDE category shall be offered to the PGDPA and PGDFM categories provided they meet the criteria, in order of merit. Therefore, graduates who have appeared the BCSE under PGDPA and PGDFM categories who have the prospect of being selected for PGDE are required to bring the original academic transcripts for validation.

Drug Test and Medical Fitness Certificate:

All the BCSE selected candidates are required to undergo mandatory pre-employment drug test for recruitment into the Civil Service. The drug test will be carried out along side placement & selection and candidates are required to bring Nu. 259/- for the drug test kit. The candidates are also required to bring along original 'Medical Fitness Certificate' issued by a competent medical doctor, during placement and selection.
